#### **COMMENDATION**

I cordially want to recommend *Muhammad in the Bible?* In this book, Mr. Lee offers us two studies - *viz*. "Is Muhammad the promised Prophet of Deuteronomy 18?"; and "Is Muhammad the promised Comforter of John 14 to16?"

The question has already been asked between Muslims and Christians as to whether the Bible speaks about Muhammad. From the side of Islam, it has been alleged that the Bible indeed speaks [positively] about Muhammad - but that Christians do not see this, or do not want to see this. Now the question is: Are Muslims right when they allege that certain portions of the Bible speak [thus] about Muhammad?

Mr. Lee has made a deep study of the portions of Scripture in accordance with which [the celebrated Muslim Scholar] Mr. A.H. Deedat has written about Muhammad. Mr. Lee's study is of importance for the Muslim, because the *Qur'an* acknowledges that light can be found in both the Old Testament and the New Testament (*Sura* 5:47-50).\* It is also of importance to the Christian, because it can help him too better to grasp what the Bible teaches about Moses and about Christ.

The explanations of both Mr. Lee and Mr. Deedat ought to be studied thoroughly. The reader can then himself draw his own conclusions as to which exposition of the portions of Scripture concerned, is correct. If we read the Bible with an open mind, it shall speak for itself.

From the heart, I therefore wish to recommend this study to Muslims and to Christians. It can be of great help where they wish to engage in a discussion about the religions they espouse. May God use such a study to illuminate the heart, mind and life of many a reader!

## **PREFACE**

The coming into being of this dissertation, has had an interesting history. During 1959, when I was yet a Law Student at the University of Cape Town and still about two years before the beginning van my theological studies at Stellenbosch, the Muslim Youth League of Cape Town organized a public debate between myself as a Christian Speaker and Mr. Sydow (a famous Muslim Leader in the Cape) as a representative of Islam.

The points of discussion on which we elenchticized on that particular occasion, were thereafter soon written down for promoting dialogue with Muslims. During 1961, when urged to do so by Rev. Dawie Pypers of the Muslim and Hindu Mission of the Dutch Reformed Church in South Africa, those recorded points of discussion were considerably expanded with a view to publication for elenchtical purposes.

However, when their immediate publication was deferred, the decision was later made to rework the manuscript into an academic dissertation - largely at the urging of <u>Rev.</u> <u>Professor Dr. Jac. J. Müller</u>, to whose influence and encouragement many thanks are due. Consequently, the manuscript was "theologized" in 1963, and again very considerably expanded. The present dissertation was then the final result. I wish to express my sincere appreciation to <u>Rev. Dawie Pypers and his Commission</u>, for kindly volunteering to duplicate it.

I would also cordially like to thank my highly respected Promotor, <u>Rev. Professor</u> <u>Dr. W.J. van der Merwe</u> for his encouragement, advice, and appreciation of this undertaking. May it then be, for him too, of both theoretical and practical value in respect of the Christian-elenchtical approach to Islam and especially the Ahmadiyya Movement.

I would further like to thank my Co-Examiner <u>Rev. Professor Dr. P.A. Verhoef</u>, for his useful tips in improving the manuscript. Inasmuch as I did not deal with the *Qumran Rolls*, the problem of the *Nah-Erwartung* and the Messianic expectation between the Old and New Testaments - he no doubt ascertained that the elenchtical approach of this dissertation was cast in the crucible of a direct dialogue with Muslims.

To my Professors, I would only say - the improvement of the manuscript is thanks to you; the remaining defects are all mine. I should, however, mention that it was by deliberate choice and out of respect toward Muslim readers that I have here used their traditional manner of spelling the name of their prophet (Muhammad). For that reason, therefore, I have not employed the suggestion of the South African Academy to spell it: "Mohammed" - except when citing authorities who spell it thus.

A particular word of thanks is due to <u>Mr. Sydow</u> and the <u>Muslim Youth League</u> of Cape Town. Without their challenge to come and defend the disputed points of discussion, this dissertation would never have been written.

I would also like to express my thanks to the <u>Islamic Propagation Centre of</u> <u>England</u>, and to the late <u>Mr. Muharrem Nadji</u> (the former Albanian-American Director of the <u>Islamic Propagation Centre of America</u>). They kindly despatched Islamic literature to me, which was invaluable in writing this dissertation.

I should also express my gratitude to <u>Mr. Ahmad Deedat</u>, Director of the <u>Islamic</u> <u>Propagation Centre of South Africa</u> in Durban and Imam of the largest mosque in the Southern Hemisphere - for his interest in the publication of this dissertation. He constantly urged me to produce it, but when I sent him a copy in its original Afrikaans he was unable to read it. Years ago I resolved to translate it into English. [But in my busy subsequent years that was never done, until after my retirement at the end of A.D. 2000.]

My sincere thanks to my wife <u>Nellie</u> may not be muted, however much she would like to remain anonymous. As always, it is she who had: to struggle to decipher my handwriting; to type out the rough copy; and then again to produce the final product both on wax stencils as well as on typing paper with carbon copies. I salute her, my "helpmate meet unto me" (*cf.* Genesis 2:18), for her Job-like patience with me (*cf.* James 5:11).

Lastly, my humble thanks to my <u>Heavenly Father</u> may not remain unmentioned. May it please Him to take this simple dissertation - the work of sinful hands - and nevertheless sanctify it for the expansion of His Kingdom!












